## Rome Police Department Monthly Report January 2018

### **Meetings/Training Attended**

During the month of January I attended Town Board and PFC meetings. Officer Upton attended Detective School sponsored by the Milwaukee Police Department. A meeting was also held at the Town Hall to plan a table top dam failure exercise that will take place at the Town Hall in February. Full time staff is in the process of completing State mandated Emergency Medical Responder Refresher Training. Sgt. Wilson, Officer Stashek and I will finish February 28. Officers Winker and Upton will finish in March.

### **Calls for Service, Citations, and Written Warnings**

Officers handled 79 calls for service, and issued 31 citations and 31 written warnings.

### **Department Activities/Announcements**

The police department still has one Officer off as a result of a February 2017 on duty motor vehicle crash. Officer Todd Johnson resigned on January 18, 2018. Officer Cory Valiquette is continuing in the field training program and will be helping fill vacant shifts at the conclusion of his field training. Part time Officers and I continue to fill open shifts.

Calls for service in 2017 were up 4% over call volume in 2018. I would like to thank the Officers for their work in 2017. I will be working on the 2017 police department report as soon as the final 2017 budget numbers are in.

Ryan Arnett was hired as Clerk of Municipal Court/Police Administrative Assistant. She will continue training for the position in February and March.
