Meetings/Training Attended

During the month of January I attended a PFC meeting, and Town Board meetings.

Calls for Service, Citations, and Written Warnings

In January officers handled 93 calls for service, and issued 69 citations and 21 written warnings.

Department Activities/Announcements

I would encourage residents to ensure that their address signs are kept clear of obstructions. This provides for quicker response from our emergency responders. During the winter months it is easy to lose sight of the importance of these signs and allow them to be covered or blocked by snow during snow removal. Please take their time to ensure your sign is visible from both directions.

The 2017 Ford Explorer was up fitted and put into service in January. The highway shop is working on removing emergency equipment on the 2006 Ford Expedition at which time it will be advertised for sealed bids as we have done with the past squads.

The marked 2017 Ford Explorer will be in in the next few weeks and will be up fitted when the weather warms up.

I am working on updates with the Town of Rome Spillman along with the City of Adams. Spillman has added some futures to our system that will allow officers to complete more in the filed on the squad computers.

I will also be working with the City of Adams PD on a grant for body cameras. Federal funding is available at this time and I feel in the near future laws will be enacted that will require the use of these cameras.

Routine maintenance was done to the fleet during January.
