During the month of December I attended Town Board and PFC meetings. Officer Stashek attended Standardized Field Sobriety Update Training in Adams. Officer Upton attended the Coordinated Community Response Team, and Crisis Response Community meetings.

Calls for Service, Citations, and Written Warnings

Officers handled 68 calls for service, and issued 21 citations and 11 written warnings.
