## Rome Police Department Monthly Report April 2018

### **Meetings/Training Attended**

During the month of April I attended Police and Fire Commission, staff, and life safety meeting with Sand Valley. Sheriff Wollin and I also met regarding updates to the Spillman Records Management Software. Officer Valiquette and Anderson are attending Emergency Medical Responder (EMR) training and will be certified as EMRs and should be licensed at the end of June. Officer Upton and I attended Death Investigation School in Rice Lake. Current and former members of the Wisconsin Department of Justice Division of Criminal Investigation (DCI) instructed the class along with an evidence technician, attorney and pathologist. The staff that instructed mostly had been assigned to major crimes. DCI will work with local agencies when these types of incidents happen should we need assistance.

### **Calls for Service, Citations, and Written Warnings**

Officers handled 82 calls for service, and issued 62 citations and 33 written warnings.

### **Department Activities/Announcements**

Officer Cody Winker represented the Rome Police Department at Adams County Kids Day which was held April 28.

Officer Stashek and I placed the regulatory buoys for the 2018 boating season. I am also interviewing candidates for seasonal recreational officer positions. We have reposted due to only receiving four applications.

The Police and Fire Commission has provided me with two names for a full time eligibility list. These applicants will also be considered for the seasonal recreation officer positions

I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Routine maintenance was done to the fleet in April.
