Rome Police Department Monthly Report June 2018

Meetings/Training Attended

During the month of June I attended Town Board meetings. Officer Stashek, Sergeant Wilson, and I attended a state mandated instructor update at Lake Shore Technical College.

Calls for Service, Citations, and Written Warnings

Officers handled 140 calls for service, and issued 81 citations and 24 written warnings. The Boat Patrol logged 148.5 hours of patrol issuing 19 citations and 6 written warnings.

Department Activities/Announcements

Again I would like to inform residents it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

We have been receiving complaints of boat traffic and water skiing after 8:00 pm on Lakes Camelot, Sherwood, and Arrowhead. As a reminder these lakes are all slow no wake after 8:00 pm.

If residents observe boating violations on a routine basis in a particular area we urge them to call the Rome Police Department so we can give these problem areas some extra attention.

We have an Officer off due to an injury he received from a suspect that was resisting arrest. He is expected to be off duty for up to six weeks.

Squad 86 was cosmetically damaged during patrol. I would like to thank ABRA Auto Body and Glass their generosity in donating time, and the paint to repair the damage.
