Calls for Service, Citations, and Written Warnings

During the month of March officers handled 87 calls for service, issued 25 citations, and 12 written warnings.

Department Activities/Announcements

Reminding residents that Governor Evers Safer At Home Order remains in place.

What is Safer At Home?

All individuals in the state of Wisconsin are ordered to stay at home or at their place of residence, with limited exceptions. Individuals who are using shared or outdoor space other than their home or residence, must, at all times and to the extent possible, maintain social distancing of at least 6 feet from another person. Individuals do not need to maintain social distancing between family members in a single living unit or with other household members.

All individuals may leave their home or residence for a number of essential activities and functions including health and safety, such as picking up medications, visits with health care providers; obtaining groceries and food, buying gas or pet food, and other activities necessary to maintain the home or residence; outdoor activities, such as walking, biking, hiking or running while maintaining social distancing (does not include contact sports such as basketball); taking care of others, including friends and pets; and the travel associated with such tasks.
