## Rome Police Department Monthly Report June 2021

### **Meetings/Training Attended**

During the month of June, I attended Town Board, staff, and Police and Fire Commission meetings. The Officers all completed mandatory firearms training and emergency vehicle operation training. Sergeant Upton attended the Dead Timber and Brush Task Force Meeting.

### **Calls for Service, Citations, and Written Warnings**

During the month of June, officers handled 156 calls for service, issued 20 citations, and 7 written warnings. The boat patrol logged 69 hours of patrol, issuing 12 written warnings.

### **Department Activities/Announcements**

A reminder to residents and guests that jet skiing and water skiing is prohibited from 8:00pm to 10:00am. Also, all boats are restricted to slow-no-wake from 8:00pm until sunrise. Officers will be stringently enforcing the boating laws on the lakes after receiving complaints of violations.

With the 4<sup>th</sup> of July just a few days away, fireworks are starting to be a problem in the area. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

Officer Wilson resigned from the Department in June. Officer Jasin will be completing field training in July.

The 2021 Ford Explorer was put into service in June. The 2013 Dodge Charger will be sold in July.

### **Vehicle Fleet/Maintenance**

Routine maintenance was done to the fleet in June.
